JOINT MOTION TO STAY PROCEEDINGS

On May 21, 2025, this Court entered a preliminary injunction barring Respondents from “remov[ing] Petitioner from the United States as an alien enemy” until “this Court has entered an order specifically setting forth the due process requirements necessary to protect Petitioner’s constitutional rights in light of the most recent Supreme Court opinions.” Dkt. 22 at 14–15. The preliminary injunction “only addresses the removal of Petitioner as an alien enemy pursuant to the Alien Enemies Act. It does not restrict the Government from removing Petitioner under other lawful authorities, including the transfer from Stewart [Detention Center] to effect his removal under the” Immigration and Nationality Act. *Id.* at 15 n.4.

The Parties hereby jointly request that all deadlines and all proceedings be stayed in this matter unless and until Respondents designate Petitioner as an “alien enemy” subject to the Alien Enemies Act. If such designation occurs, the Parties will jointly notify the Court and propose a briefing schedule on the issue of what process is appropriate.
